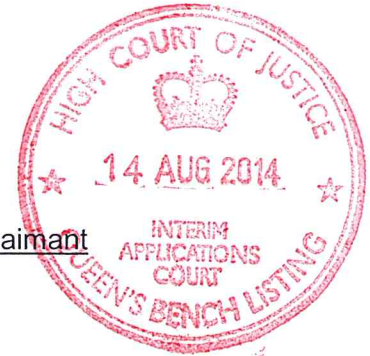

ORDER FOR AN INJUNCTION

PENAL NOTICE

This order prohibits you from doing certain acts. If you Louis Karmios disobey this order you may be found guilty of contempt of court and you may be sent to prison or fined or have your assets seized.

If you Get Bike Credit Limited disobey this order, you may be held to be in contempt of court and may be fined or have your assets seized.

Any other person who knows of this order and does anything which helps or permits the Defendants to breach the terms of this order may also be held to be in contempt of court and may be sent to prison or fined or have his assets seized.

You should read the terms of this order and the Guidance Notes very carefully. You are advised to consult a solicitor as soon as possible.

THE APPLICATION

An application to the Court was made by counsel for the Claimant. The First Defendant appeared in person. The Judge read the witness statements listed in the Schedule hereto.

This order relates to land known as Orion Park, Northfield Avenue, West Ealing London W13 9SJ, shown edged in black on the attached plan ('the Site') and to a building marked as 'Unit C' thereon.

## THE ORDER

IT IS ORDERED THAT UNTIL TRIAL OR FURTHER ORDER -

1. The Defendants be forthwith restrained from causing or permitting motorcycle training from taking place on the Site outside Unit C.
2. Costs in the case.

## GUIDANCE NOTES

### Effect of this Order

A Defendant who is an individual who is ordered not to do something must not do it himself or in any other way. He must not do it through others acting on his behalf or on his instructions or with his encouragement.

A Defendant which is a corporation and which is ordered not to do something must not do it itself or by its directors, officers, employees or agents or in any other way.

The requirements of this order apply to each Defendant.

It is a contempt for any person notified of this order knowingly to assist in or permit a breach of the order.

### Variation or discharge of this order

A Defendant or anyone notified of this order may apply to the Court to vary or discharge this order, but anyone wishing to do so must give notice in writing to the Director of Legal and
